### SECTION 4 – FIRST AID MEASURES

<b>Scheduled Poisons:</b>	Poisons Information Centre in each Australian State capital city can provide additional assistance for scheduled poisons. (Phone Australia 13 11 26) or a doctor (at once).

### SECTION 6 – ACCIDENTAL RELEASE MEASURES

**Spills:**

**Personal Precautions:** In case of spill, particular danger of slipping on leaked/spilled product. Isolate hazard area and deny entry.

**Environmental Precautions:** Do not allow to enter drainage system, surface or ground water. In the event of product entering waters or drainage system, or polluting soil or plants contact the Environmental Protection Authority or your local Waste Management Authority.
